8. Reports

A. *Environmental Monitoring Data & Operations* – Ms Julie Thomas presented a PowerPoint presentation to the committee. The presentation contained an update on approvals, mine operations, rehabilitation, complaints and the results of the environmental monitoring data (weather, dust, water, blasting and noise), for the previous quarter (*October – December 2015*) at the mine site.

B. *Report Discussion* –

Mining Update

- i. Mining activities continued in Open Cut 1
- ii. 338,084 tonnes of coal was mined and 1.53 million cubic metres of waste was removed during the reporting period.
- iii. 355 hours was lost due to environmental conditions.

W. Muswellbrook Project

- Hydrogeological drilling program continued for installation of additional monitoring bores and piezometers
- Newsletter #24 prepared and issued to stakeholders
- Finalisation of Co-Ag learning venture between MCC and St Joseph's College Aberdeen

Sandy Creek Project

Continuation Project

- Meetings have been held with Muswellbrook shire Council, Environmental Protection Authority, Department of Primary Industries – Water and Division of Resources and Energy to discuss project and to understand their expectations
- A consultant has been engaged to assist with the preparation of the Environmental Assessment. This is to be based on feedback from the regulators and guidelines for environmental assessments
 - Technical studies – noise and blasting, air quality, land and soil, rehabilitation, biodiversity, water resources, visual, economics and social impact assessment.

Management Plans and Environmental Audit

5 yearly review of environmental management plans has been finalised –

- Site Water Management Plan, Surface & Groundwater Monitoring Plan, Erosion and Sediment Control Plan, Visual Amenity and Landscape Management Plan, Waste Management Plan, Dust Management Plan, Blast-Vibration Management Plan, Noise Management Plan, Lighting Management Plan – all updated and commenced implementation 1 December 2015

- Environmental Management Strategy, Spontaneous Combustion Management Plan, Archaeology and Cultural Heritage Management Plan, Soil Stripping Management Plan, Final Void Management Plan, Bushfire Management Plan, Land Management Plan – being updated and commenced implementation 1 February 2016
- Copies of all Management Plans have been sent to CCC members

Weather

- Windroses*: Primarily south-easterly wind directions during the reporting period which is consistent with seasonal expectations.
- Rain*: Below average precipitation in October and November with above average in December.

Dust

- Dust Deposition*: Average levels at all non-mine owned properties were within the compliance levels. Gauge DM10 is located on MCC mine owned land adjacent to mining operations.
- TSP (Total Suspended Particulates)*: All sites below predictions and criteria.
- PM₁₀*: All below criteria.

Water

- Quality of surface water remained generally consistent with previous results during the reporting period. Ground water has an increase in pH & EC over the last couple of months. Underground water levels also consistent and stable.

Blasting

- There were 28 blast events conducted at MCC Open Cut Operations between 1 October and 31 December 2015. All results for the reporting period were below criteria.

Complaints

- The complaint history until February 2016 was presented to the CCC. There was a general discussion around the types of complaints and where the complaints were coming from. These were mainly odour complaints.
 - Glenda Watts made a comment that experiences odour and noise at her property and asked where it is coming from. *Response* – Noise is potentially in Open Cut 1 only, odour could be Open Cut 1 or Open Cut 2.
 - Malcolm Ogg commented that odour is about 90% of the complaints. Where are the complaints coming from? *Response* – Generally the complaints are coming from 3-4 people from a variety of areas. Grant Clouten commented that the continuation project will remove the underground workings and will remove the source of the odour.
