1.	Welcome, Introductions and Apologies – MJS welcomed everyone to the meeting.	
2.	Acknowledgement of Country - The Chair acknowledged the Traditional Owners of the land on which the meeting is being held and their continuing connection to land, water, and culture, paying respects to their Elders past, present and emerging and any Aboriginal person present at the meeting.	
3.	Declaration of pecuniary or other interests - RG’s property falls within the zone of affectation. MJS advised his expenses are borne by the Proponent.	
4.	Minutes of the previous meeting – The minutes of the meeting of 4 September 2025 were approved on 8 October 2025. EOH enquired when the Glentarkie Housing Complex was officially opened. AW advised this occurred on 3 September 2025.	
5.	Actions 5.1 AW to advise on membership of the Native Title liaison committee. <i>Response: Ongoing – the Committee has not held a second meeting. AW will share details of the Liaison Committee when available if the Members agree to the information being shared.</i>	
6.	Correspondence 6.1 Jamie Chaffey MP – Responding to in-pit HV tyre disposal correspondence. Advising that the Australian Tyre Regulators’ Association made a submission to the Federal Inquiry into Australia’s Circular Economy calling for the development of a national product stewardship scheme for HV tyre disposal. 6.2 Hon. Penny Sharpe MLC – Responding to in-pit HV tyre disposal correspondence. Advising of the stewardship approach being provided by the EPA to find better ways to manage end-of-life tyres. EOH commented that more information on the EPA approach is required. It was agreed that the Chair contact the Director Operations, Western regarding more information on the EPA’s approach to the issue.	ACTION: MJS to contact the EPA Director Operations, Western regarding more information on the EPA’s approach to HV tyre recycling.

7.	<p>Proponent's Report <i>A copy of the Proponent's Report is attached to the minutes.</i></p> <p>Hunter Gas Pipeline AW presented maps detailing the location of the proposed Hunter Gas Pipeline through five Boggabri properties owned by BCOPL. EOH highlighted recent comments by the Premier that compulsory acquisition provisions may be utilised to facilitate acquisition of land for the pipeline.</p> <p>Correspondence AW stepped the Committee through the list of correspondence, highlighting the more significant matters:</p> <ul style="list-style-type: none"> • NSW Department of Planning Housing and infrastructure (DPHI) AW advised the Groundwater Management Plan had been approved. • Environment Protection Authority (EPA) AW advised that a warning letter and penalty notice had been received in respect of the overpressure exceedance (blast) that occurred on 18 January 2025. A fine of \$30,000 has been imposed – consideration is being given whether to appeal the decision. • Biodiversity Conservation Trust AW advised that the Biodiversity Conservation Trust will shortly undertake its annual inspection. EOH questioned how many conservation agreements had been established. AW advised 27, with three other land areas being transferred to National Parks for management. The deeds for the land transfers are expected to be finalised by the end of 2025. • Department of Climate Change, Energy, Environment and Water AW advised that DCCEW will be conducting an audit on BCOP's 2009 EPBC Conditions in November 2025. • Narrabri Shire Council The long-term plan for the housing commitment is ongoing. The Chair enquired what the issues were in relation to occupation of the Glentarkie units. AW advised that there were outstanding matters that precluded issue of the Occupation Certificate. <p>Operational Update</p> <ul style="list-style-type: none"> • Production Targets It was noted that 5.4 million tonnes had been mined to date in 2025.

AW outlined the key projects for 2025:

- Finalise edge of pit maintenance and fuel facility.
- Expansion of workshop and warehouse.
- Solar Farm commissioning.
- Glentarkie construction
- Relocation of main mine water dam.

AW commented that dam construction had been delayed due to wet weather.

AW advised that the response to submissions report was submitted to the DPHI on 27 October 2025. EOH commented that the report was not on the Department's website. AW responded that it may take a few days to upload.

Housing Voluntary Planning Agreement Update

AW commented on discussions with Narrabri Shire Council regarding housing for doctors in Boggabri. RG sought clarification on proposal and the need for medical practitioners in Boggabri. AW indicated that funding for a duplex facility for doctors is budgeted in 2026.


2025 HV tyre disposal

SP advised that 347 large mining tyres have been disposed of in-pit to date this year. She indicated that BCO intends to recycle tyres with a radius of 51 inches and below over the next two years. She noted 56 tyres had been recycled over the last six months. AB enquired where tyres are taken to be recycled. SP responded that they are still using the

AB advised Narrabri Shire Council is investigating the potential of a tyre recycling plant in Narrabri Shire.</p> <p>Exploration 2025 AW advised that the exploration process is ongoing but will be completed by end of November.</p> <p>Community Complaints The Committee noted the complaints' bar chart.</p> <p>Sponsorship 2025 It was noted that \$254,506 had been provided in sponsorship to organisations or events to date in 2025.</p> <p>Current Vacancies The Committee noted the current list of vacancies.</p>	
8.	<p>Other Agenda Items</p> <p>9.1 Rehabilitation and Modification 10 EOH commented on the June figures presented previously for euthanised or relocated fauna. It was agreed that the genus and species should be added to the Proponent's slide prior to placement on the website. SP advised that some 30 hectares will be cleared in 2026. EOH noted that the revised Rehabilitation Strategy is not on the website. AW indicated she would follow up. She advised that the revised strategy related to changes to the area of the Mining Lease not the method of rehabilitation. <i>Chair's note: The Proponent advises that the Rehabilitation Strategy has only been submitted for consultation. Once approved, the latest version will go on the website.</i> EOH referenced Authorisation 355 (A355) and sought clarification regarding how it has changed over time. AW explained that A355 allowed for exploration activity. Part of A355 is now Mining Lease 1883. A Mining Lease allows for extraction of coal. AW discussed the process and explained the need for consultation and the relinquishing of a Native Title claim. EOH enquired what proportion of A335 will transfer to a Mining Lease? AW responded that about 70% will be under a Mining Lease, with the balance remaining as an Exploration Lease as there is no viable coal in that area. RG requested clarification on the difference between a Coal Lease and a Mining Lease. AW advised that 'Coal Lease' is an old term, with Mining Lease being the current term. RG asked what the 'end of life' date of the mine is? AW advised it is currently 2036 – if MOD 10 is approved, will increase the mine footprint and extend the life of mine to 2040. An updated Final Void and Mine Closure Plan has been submitted to the Resources Regulator and the DPHI in accordance with Condition 73 of the consent for the mine.</p>	<p>ACTION: SP to add genus and species of euthanised or relocated fauna to slide package.</p>
9.	<p>General Business</p> <p>9.1 Regional Air Quality Monitoring Presentation - EPA MJS advised that the EPA was unable to make a presentation on Regional Air Quality Monitoring at the Boggabri</p>	

	<p>Tarrawonga Maules Joint Mines CCC meeting scheduled for later in the day. Consequently, the meeting has been cancelled.</p> <p>9.2 PFAS – Narrabri Water Supply</p> <p>AB advised that Narrabri is experiencing a water contamination issue due to high levels of per- and polyfluoroalkyl substances (PFAS) in its water supply, which led to two of the town's three bores being shut down in July 2025. The contamination is caused by a group of chemicals, PFAS, often found in firefighting foams, nonstick cookware, and cleaning products and is commonly known as “forever chemicals”. AB questioned whether testing for PFAS is conducted at the Boggabri mine. AW responded that water quality testing is undertaken but not for PFAS. AB explained that a filtration system is required on the Narrabri water supply to remove the PFAS – Narrabri Shire Council is seeking NSW Government support to finance the filtration facility.</p> <p>9.3 Boggabri Doctors</p> <p>RG questioned the availability of doctors to support the Boggabri Multipurpose Service – questioning how many doctors are required. SP understood that at night doctors operate on an on-call basis.</p> <p>Meeting closed 10.00 am</p>

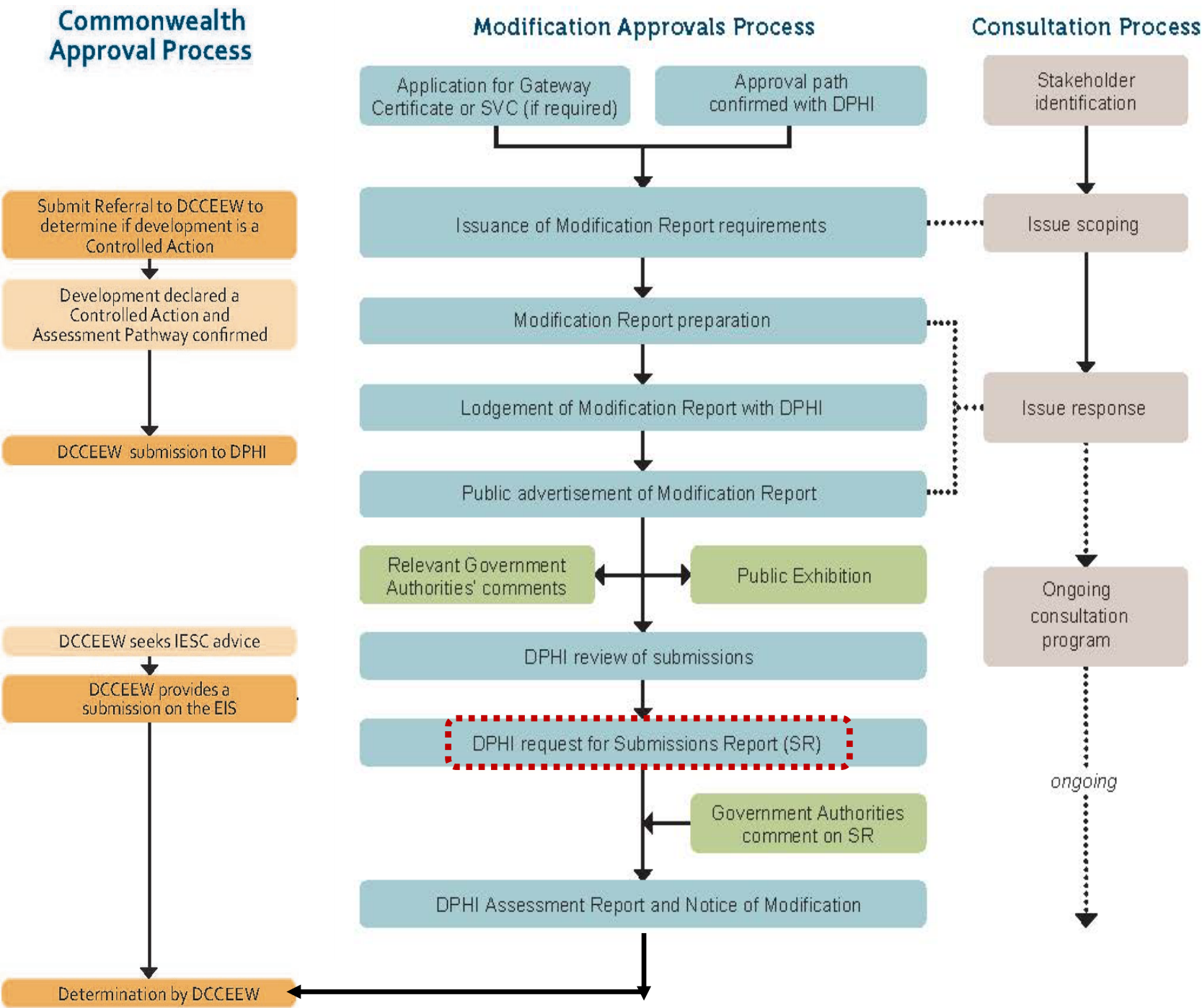

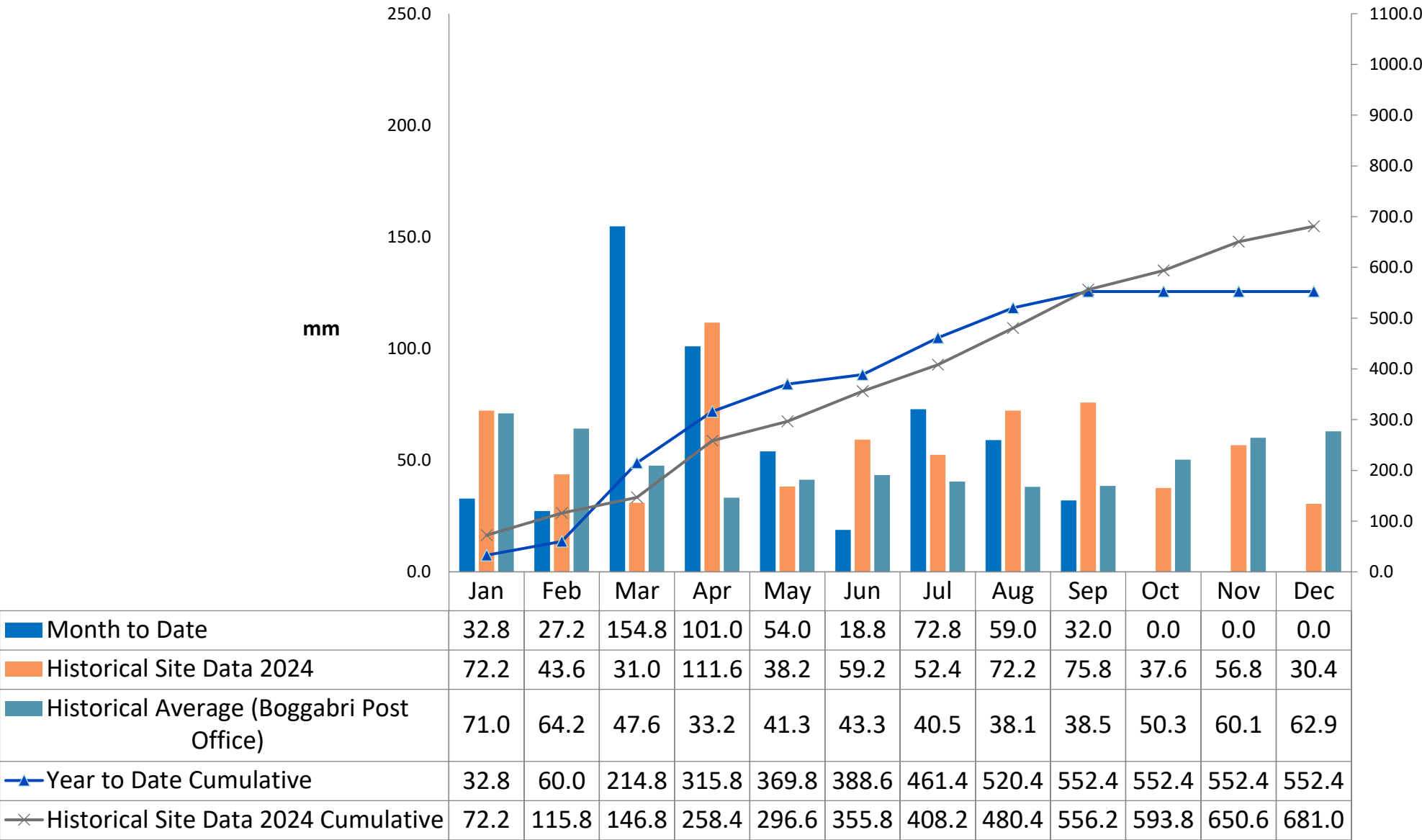


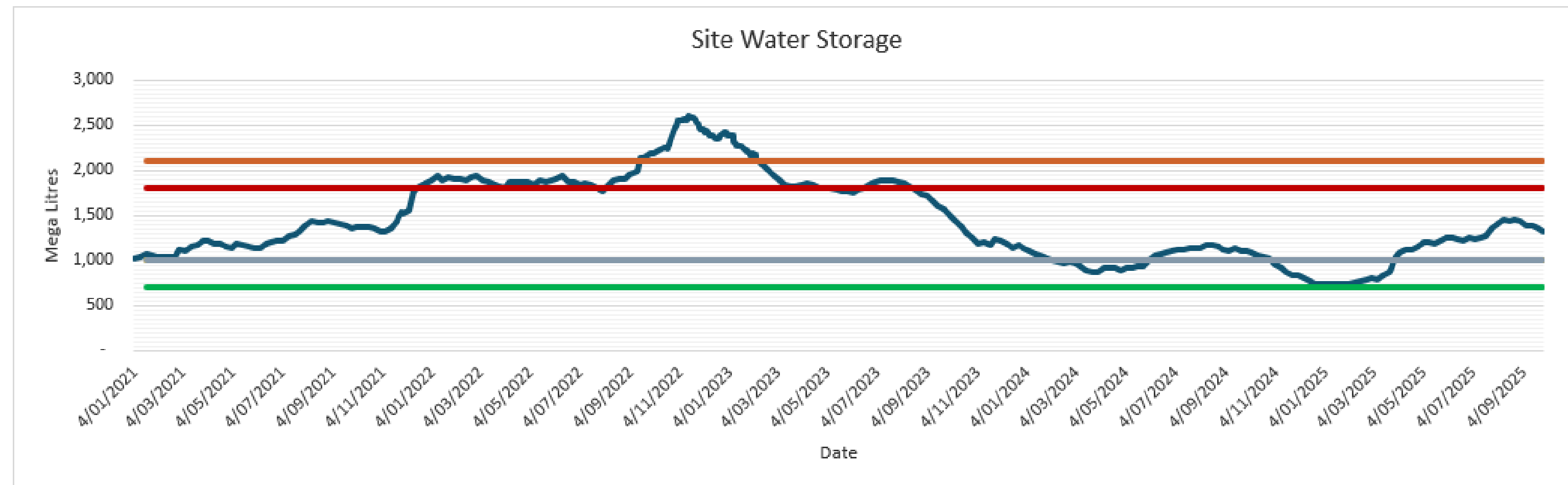

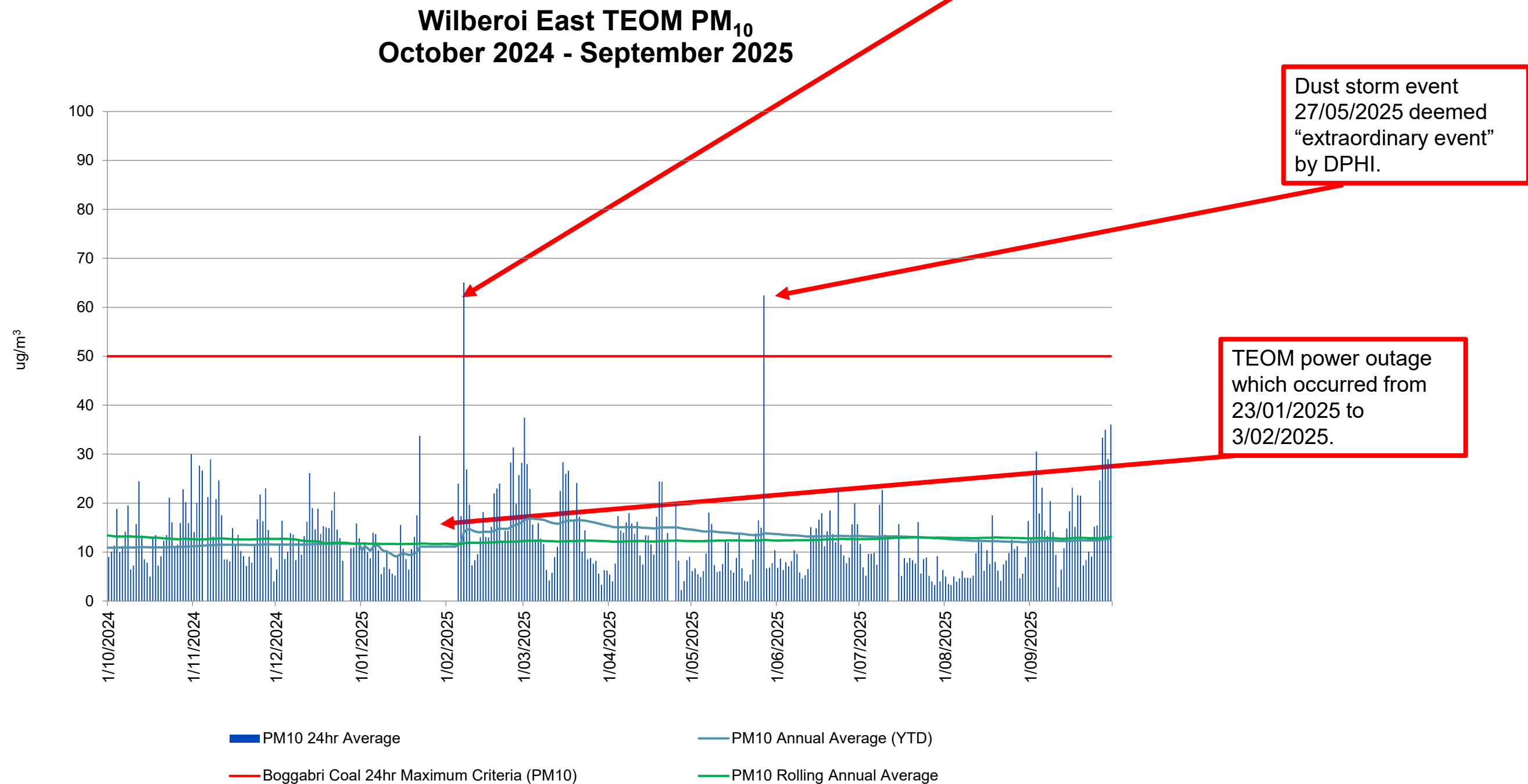

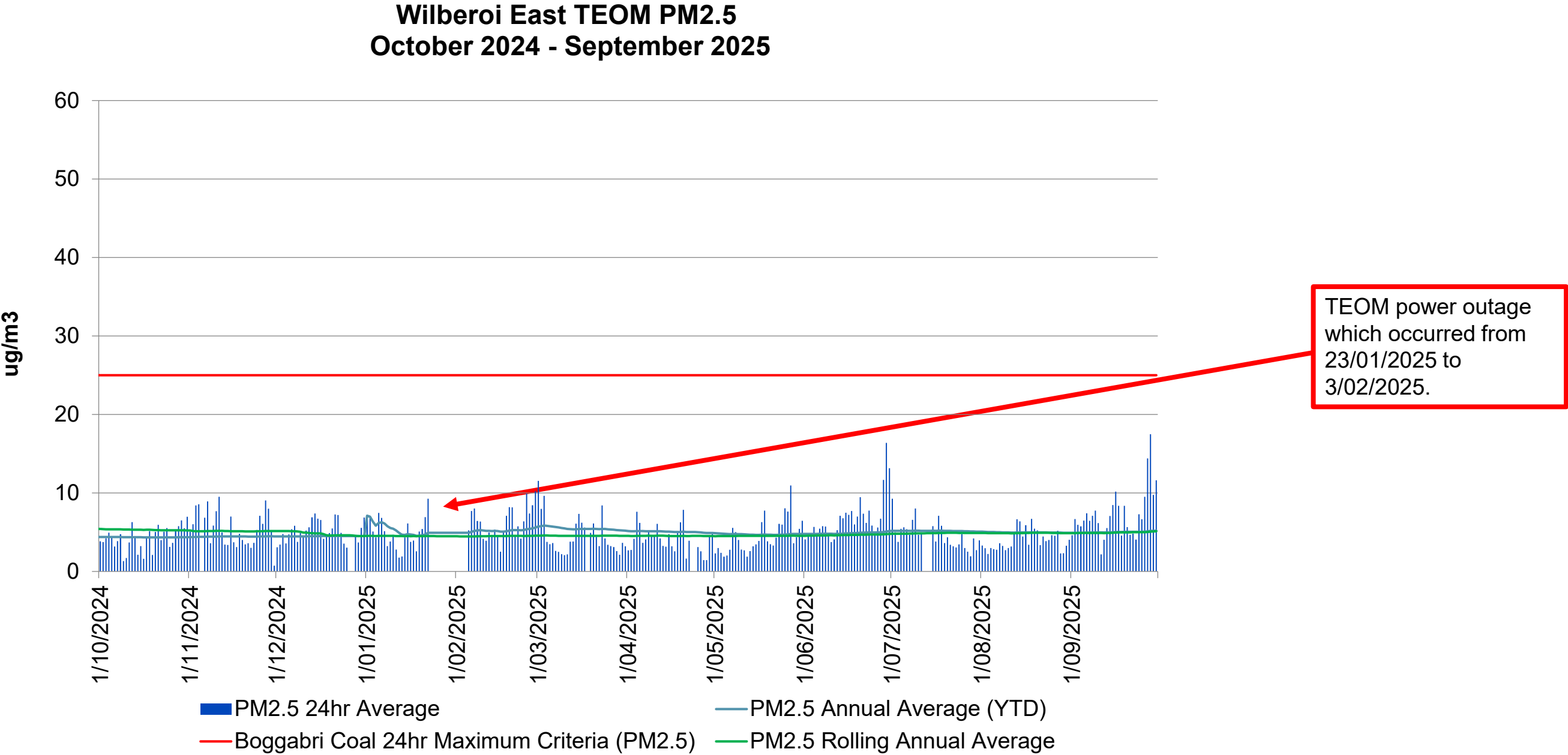
