RG questioned whether the volume of coal extracted was the highest during the mine's operation AW responded, yes.

#### Modification 10 update

AW provided an overview of progress with the Modification 10 proposal, noting that it is anticipated that the application will be lodged in the second quarter of 2025. AW highlighted the community survey and the online link – it was suggested that hard copies be provided to members of the Maules Creek community to ensure all are aware of the survey and modification proposal.

#### Housing Voluntary Planning Agreement Update

AW advised that construction has commenced at the Glentarkie project at Boggabri with construction expected to be completed in Q2 2025. She added that there is continuing discussion with Narrabri Shire Council regarding the remaining housing commitments.

#### Water and Rainfall

The Committee noted the graphs and tables associated with water take volumes and rainfall. In respect of site water storage, RD questioned whether water is being pumped from the existing dam in preparation for its relocation. AW responded, no – it is not necessary at present.

#### Air Quality, Noise and Ground Water Monitoring

The Committee noted the contents of the graphs and tables associated with noise and air quality assessment.

#### 2024 HV tyre disposal

AW reported on the first tyre recycling trial, with 60 tyres in total being collected from site on 30 October 2024 and the 17 December 2024. Rubber crumb from the tyres has been used for the making of hockey courts at Box Hill in northwestern Sydney.

RD asked why the tyres were sent to Stapylton, Queensland. SP explained the selection process and advised that following a due diligence assessment of two operators Boggabri Coal decided to work with Carroll Engineering Service. RD questioned, "Where to from here? Will you do it again in 2025?" SP explained the challenges with transporting tyres. Tyres with a radius of 51 inches and below do not require escorting larger tyres have escorting requirements. MN commented that if there was a mobile plant or a permanent local site more tyres could be recycled. AW explained there are licensing requirements for the processing of waste and waste tyres.



# **Boggabri Coal Environment Protection Licence 12407**

BCO Environment Protection Licence is Category B, Level 1 (low risk).

The EPA's risk-based licensing system is used to ensure that all environmental protection licensees receive an appropriate level of regulation; based on the risk they pose to human and environmental risk.

The EPA uses a risk assessment tool to evaluate each site individually. The tool considers the following aspects:

- The day-to-day operations of the site, including the type (air, odour, noise, water) and the nature of the emissions. ۲
- The risk of pollution. •
- The licensee's environmental management performance, which considers the licensee's compliance history, management systems, and improvement programs. ۲

The day-to-day operations and risk of pollution make up the sites regulatory priority; 1. 2, or 3 (high, Low, Moderate). The Licensee's management performance makes up the environmental management category (A, B, C, D, or E).

The regulatory priority and management performance are then used to calculate the sites overall environmental risk using the table below:




- Idemitsu are a member of the NSW Minerals council Tyre Stewardship Working Group.
